### **RULES OF MEMBERSHIP - 2022**

- Membership renewals received by 18th February 2022\_will qualify for a \$20 early bird discount (offer not applicable for Studio Membership)
- Membership Fees are concurrent with the calendar year, regardless of the time of year joined.
- Members (MSFD) or Associate Members (ASFD) are entitled to attend Conventions, Workshops,
  Masterclasses or Private Inservices
- You must be a Full Member of SFD to submit students for exams or Masterclasses
- The onus is on Members to keep SFD updated with any changes to their contact details.
- Further information about SFD can be found in the updated SFD Manual which will be distributed in February 2022 to all current financial Full Members (MSFD).

## SFD MEMBERSHIP INFORMATION & FEES

All SFD teachers must be financial members of Southern Federation of Dance. Membership renewal is due on 31<sup>st</sup> December each year. Due to hardships faced as a result of Covid-19 in 2021, this renewal date is being extended to 18th February 2022 to enable studios to receive Term 1 income before payment is due. We are also extending our \$20 early bird special discount until 18th February 2022.

# **Conditions of Membership**

- (1) Southern Federation of Dance reserves the right to alter any of the above specifications at any time.
- (2) Any of the below memberships can be terminated/revoked at the discretion of the Southern Federation of Dance Committee.
- (3) Southern Federation of Dance reserves the right to refuse membership to any person.

#### Associate Member (ASFD) - fee \$110.00 per annum

Associates (friends) of Southern Federation of Dance may be students, student teachers, unqualified teachers or other interested persons.

(1) An Associate of Southern Federation of Dance may not enter students for examinations.

An Associate is entitled to:

- Receive all letters and newsletters
- Vote
- Be nominated and voted onto the Southern Federation of Dance committee of management
- Assist on Southern Federation of Dance sub-committees
- Attend syllabus inservices, learning days and masterclasses
- Attend workshops

#### Member (MSFD) - fee \$170.00 per annum

To qualify for Membership to Southern Federation of Dance the applicant must be able to:

- (1) Provide evidence of Southern Federation of Dance's minimum required qualifications:
  - (a) Southern Federation of Dance Teaching Certificate in classical, jazz or tap, or
  - (b) Teaching Qualifications in another method eg; RAD, ISTD, BBO, ATOD or

- (c) A tertiary qualification in dance or
- (d) A tertiary qualification in education **and** have passed Intermediate or Advanced Classical with a recognised society **eq**; S.F.D. RAD, ISTD, BBO, ATOD *or*
- (e) Have been running own dance school for a minimum of 10 years, or
- (f) Have been teaching consistently on a permanent part-time basis at one or more dance studios for a collective period of at least 10 years list of studios and reference names, must be provided.
- (2) A Member is entitled to:
  - Enter students for exams
  - Receive all letters and newsletters
  - Vote
  - Be nominated and voted onto the Southern Federation of Dance committee of management and may also hold an executive position
  - Enter students into S.F.D Scholarship Competitions (refer to S.F.D Scholarship Rules)
  - Attend syllabus inservices, learning days and masterclasses
  - Attend workshops
  - Enter students for classes with guest teachers
  - Purchase syllabus

## Studio Membership (fee \$500.00 per annum)

A Studio Membership comprises one Full Member and up to four Associate Members.

To qualify for a Studio Membership of Southern Federation of Dance the applicant must be:

- (1) A Full Member of Southern Federation of Dance and be the Director/Principal of his/her own school of dance.
- (2) The Full Member may nominate **four** teachers within their studio who will qualify as *Associate Members*. The Associate Members will be nominated annually and are non-transferable. The nominated Associate Members will *not* have to pay the \$10 joining fee.
- (3) The same conditions and entitlements apply to the Full Member and Associate Members within the Studio Membership structure.
